

Scholarship Application

Dear Student:

The members of Pacific Northwest Grain & Feed Association are pleased to announce our plans to award multiple scholarships to qualified applicants who are seeking careers in Agriculture, Agribusiness or other Ag-related fields (other career fields will no longer be accepted).

As the cost of college education continues to increase, obtaining an advanced education is becoming harder to achieve. Our scholarship program is dedicated to helping top Ag students reach their academic potential and career goals, while responding to the financial pressures placed on their families.

To qualify for this award, applicants must be high school seniors, college freshmen and/or sophomores, who have either been accepted, or are currently enrolled in a 2- or 4-year accredited college or university, and are seeking careers in Agriculture and/or Ag-Related Business or other related fields*. Previous recipients of the PNWGFA Scholarship are not eligible to apply again. The deadline for applying for these awards is April 4, 2025, so act now!

*This is a change in our program from previous years: Applicants must be in an Ag-related field to be eligible for a PNWGFA 2025 scholarship award.

2025 PNWGFA Scholarship Applications must be postmarked (or electronically dated) no later than April 4, 2025.

The 2025 scholarship application is currently in a PDF fillable format. We hope to publish an online version on www.pnwgfa.org in the future. The onus falls upon the student to ensure <u>all</u> required sections are correctly submitted and received by PNWGFA prior to the stated deadline. This includes Letter of Recommendations. Partial applications will not be considered.

The recipients of the Pacific Northwest Grain & Feed Association Scholarship financial awards will be notified by the end of May 2025 (via phone and/or email). Special recognition to the membership will be given at the 2025 Annual Convention June 19, in Whitefish, Montana. Recipients are welcome, but not required, to attend this event.

Instructions:

Following these five steps will improve your chances of being selected as a scholarship recipient:

- 1. Type or print the application.
- 2. Complete and return application as soon as possible. The application deadline is April 4, 2025.
- 3. Scholarship awards are based on the applicant's GPA, Work Experience and Leadership Qualities, and Applicant's Statement, with a possible total of 100 points. Failure to complete one or more sections of the application will likely disqualify your application. (*See Eligibility and Application Procedure sections below.)
- 4. Use the space provided, and be as concise as possible. Within reason, additional information may be included on supplemental sheets.
- 5. Recipients of the scholarship awards will be notified by the Association by the end of May 2025. Funds will be sent to the scholastic institutions in early-to-mid-August. All applicants will receive notification (via email) by mid-June of the scholarship year.

Eligibility:

- 1. The mission of the PNWGFA Scholarship is to support the educational goals of students seeking careers in Agriculture, Agribusiness or other Ag-related fields (other career fields will no longer be accepted).
- 2. Applicants must be high school seniors, college freshmen or sophomores who have either been accepted or are currently enrolled in a 2- or 4-year accredited college or university. (A Student ID number is required for fund distribution.)
- 3. Applicants may only be awarded a PNWGFA Scholarship once; previous winners not eligible again.

Application Procedure:

The following must be submitted by April 4, 2025:

- 1. Complete Scholarship Application (including all required statement pieces).
- 2. A letter of introduction and recommendation letter.

Selection Process:

- 1. The scholarship recipients are selected on the basis of academic record, potential to succeed, demonstrated leadership, extracurricular accomplishments, work experience and an evaluation by a counselor or advisor.
- 2. All recipients must enter school no later than the fall term following the announcement of the scholarship.

Administrative Procedure:

- 1. Award checks (with designation letter or form) will be mailed to the college or institution in early-to-mid August. Checks cannot be mailed directly to student.
- 2. If an awardee changes college or institution, PNWGFA must be notified immediately. If not notified by August 1 of given year, the award may be nullified.
